Programme Aims

MPA is a one-year full-time or two-year part-time taught postgraduate programme offered by the Faculty of Arts and Social Sciences with support from the School of Business and School of Communication.

We also cooperate with the University of Chinese Academy of Social Sciences (UCASS) and George Mason University (GMU) in international student and academic exchange opportunties.

As China continues its rapid development, government officials, civil servants, and administrators in both public and business sectors realize the need to better understand policy and public affairs at local, national and international levels.

MPA has been emphasizing different aspects of government policy and public affairs. A global and comparative perspective in the courses signifies the Programme's uniqueness and usefulness to the public and private sectors. UCASS's expertise in public affairs in the Mainland is also invaluable.

The Programme is designed to accomplish the following objectives:

(i) To provide students with a solid foundation in public administration, such as in Hong Kong and Mainland China, and also from a comparative and global perspective;

(ii) To illustrate the relation to finance, economy, media, law, globalization, health and management aspects of the public affairs;

(iii) To develop students' ability in the management of human resources, finance, leisure and public amenities;

(iv) To enable students to become reflective and critical administrators with the ability to assess and respond to the changing needs of the society.

UCASS Exchange

Visit relevant government departments and Nonprofit-making organizations in Beijing and experience the management and operation of the organizations.

The Programme will offer experiential learning field trips in other regions, including Singapore, Vietnam, and Taiwan, to understand overseas' government and NGO public administration operation.

Academic Expertise

Teaching team is drawn from the experts from HKBU, the UCASS (Beijing) and the George Mason University (Virginia). Overseas scholars and prominent public policy-makers will be invited to give guest lectures.

Individual Research

Students shall choose a topic of interest for their project and the Programme will match their topic with individual academics fortheir research learning.

Academic Prize

Students who obtain the cGPA 3.44 (Merit) or 3.67 (Distinction) or above will be eligible for the academic prize.

MPA Exchange Tour

MPA has launched the UCASS Exchange Tour (as a part of POLS 7080 Fieldwork Learning in China and Overseas Public Administration course) every summer since 2014.

Students will visit relevant Beijing's government departments, NGOs, and their officials during the exchange period. For example, National Intellectual Property Administration, Red Cross, Xiaomi, China Foundation on for Poverty Alleviation, Palace Museum and etc.

It provides a valuable opportunity and practical experience for the MPA students' understanding of China's management and operation in public administration. Over the years, MPA continues to explore exchange tours in Singapore, Vietnam, Taiwan, etc.

Career Prospects


The career prospects of MPA graduates are:

1. Civil service, including Police Force, Customs and Excise Department, Correctional Services, Immigration Department, Fire Services Department and other government departments such as Office of the Ombudsman, Water Supplies Department, Buildings Department, Leisure and Cultural Services Department and so on.

2. Non-government organization or sub-vented institution including Hospital Authority, Red Cross Society, Radio Television Hong Kong (RTHK), Educational Institutions, District Council, The Mass Transit Railway (MTR) etc.

3. Private sectors include the consulate, bank, insurance company, hotel, publishing company, IT Company, telecommunications, education centre.

The background of the MPA is useful and offered me a lot of opportunities for my future career. Indeed, this program provides the keys to understand Asian policy, especially how decisions are made, how views are created, how press works etc... Entry Requirement

Application for admission to the MPA Programme should possess

a) A Bachelor's degree (in any discipline) from a recognized university or comparable institution;

b) OR a qualification deemed to be equivalent.

c) fulfill university English language requirements, satisfy at least one of the following requirements on English Language Proficiency (for applicants whose first degree was obtained from non- English-medium institutions):

- 1. TOEFL: 79 (internet-based test);
- 2. IELTS (Academic): Overall Band at 6.5;
- 3. CET-6 (College English Test band 6): 450

d) Applicants should achieve a minimum of cGPA of 2.60 for those not meeting the minimum admission requirements but possessing outstanding work experience and recommendation letter (s) in NGOs, public sectors or government departments, may be invited to undergo an interview for admission.
